### **Entry Terms and Conditions**

The competition is open to residents of Australia aged 18 years or over except employees of Living Positive Victoria and anyone judging the competition.

There is no entry fee and no purchase necessary to enter this competition.

Only one entry will be accepted per person. Multiple entries from the same person will be disqualified.

Closing date for entry will be 5pm, Wed 31 May 2017. After this date no further entries to the competition will be permitted.

The description of the competition and how to enter are as follows:

Snap a photograph that most represents your resilience to HIV along with a statement of up to 50 words that describes what gives you the resilience you need to stamp out HIV stigma in your life. You can make it lively, reflective, solo, group, natural or built, but most of all, make it about you. Also include a short description of who you are. All entries will be exhibited at The Atrium, Federation Square in Melbourne between Tue 20 - Sat 24 June 2017. Winners will be announced at 6pm, Tue 20 June, at the exhibition launch. Entries will be judged by a panel of ENUF Ambassadors.

Photographs must be provided in high res jpeg format.

Only photographs deemed to be of 'G' rating will be accepted. Entries will be rated at the sole discretion of the promoter.

It is the responsibility of the entrant to ensure that his/her entry is compliant with Australian copyright law and it is to be understood that the entrant becomes personally liable in the event of any breaches of copyright relating their entry.

The promoter reserves the right to cancel or amend the competition and these terms and conditions without notice in the event of unforeseen circumstances or any actual or anticipated breach of any applicable law or regulation or any other event outside of the
